Type of the procurement procedure: Qualification procedure pursuant to the articles 34 and 124 of the Public Procurement Act («Official Gazette of the Republic of Serbia» no. 124/12)

Type of procurement: provision of services in the area of water management

Description of works: execution of works in the area of water management, i.e. construction, rehabilitation, adaptation and revitalization of water supply and sanitation networks and structures in the area of the Novi Sad City, name construction work, designation 45000000 (mostly).

In the case of the qualification procedure – period for which qualification is recognized: Qualification is recognized for period of 30.04.2014.-30.04.2018.

Conditions for the recognition of qualification on the qualification procedure: <u>Tenderer must meet mandatory and additional requirements for participation in the said tender procedure as provided for in the articles 75 and 76 of the Public Procurement Act and the tender documentation.</u>

Conditions under which Tenderer's authorised representatives may attend Tender opening: Tender opening may be attended by the Tenderer's authorised representatives. Persons who wish to witness the Tender opening should bring with them a letter duly signed and sealed by the Tenderer authorising them to attend the Tender opening.

Manner of tender submission and deadline for submission of tenders: Tenders shall be submitted in a sealed envelope (bearing Tenderer's bearing official stamp across the seal) so that during opening it can be determined that they are opened for the first time.

On the back of the envelope shall be written: name and address of the Tenderer, phone number and contact person.

Tender may be submitted independently, with subcontractor or as a joint tender. The tenderer who submitted tender independently, can not simultaneously participate as a member of a group of tenderers (joint tender) or as a subcontractor. Tenderer may participate as a member of a group of tenderers only in one joint tender.

Place, time and manner of Tender opening: All tenders received within the deadline for submission of tenders, i.e not later than 31th October 2016. godine by 12,00 o'clock shall be opened. Any Tender received after the deadline prescribed will be declared as late and returned unopened to the Tenderer.

Tenders received within the prescribed deadline shall be opened publicly in the registered seat of the Contracting Authority, Masarikova 17, on 31th October at 12,15 o'clock.

Contract award decision: Award decision shall be passed not later than 25 days after tender opening.
